

### **NOVEMBER 2025**

\*Available to Medicare-eligible outpatients with an established practice relationship by being MyMedicare registered at the practice or having attended face to face in the past year. This requirement does not apply to children <12mths; patients with COVID-19 isolating under a public health order; a natural disaster-affected area; patients attending an Aboriginal Medical Service; those receiving urgent unsociable after-hours care; patients who are homeless, receiving services for a bloodborne virus, sexual and reproductive health or focused psychological strategies. The 30/20 rule applies to phone items.
